KNOW ALL BY THESE PRESENTS, that the undersigned hereby makes, constitutes and appoints Benjamin R. Clouse, signing singly, as the undersigned's true and lawful attorney-in-fact, with full power and authority as hereinafter described on behalf of and in the name, place and stead of the undersigned to:

- (1) seek, obtain or maintain filing codes with the United States Securities and Exchange Commission, including submission of Form ID;
